

14	"Section 6. Allotment and management of funds and lapse
15	date. All funds appropriated by this act shall be
16	allotted, managed, administered and accounted for in
17	accordance with applicable laws, including, but not
18	limited to, the Financial Management Act of 1979. The
19	allottee shall be responsible for ensuring that these
20	funds, or so much thereof as may be necessary, are used
21	solely for the purpose specified in this act, and that
22	no obligations are incurred in excess of the sum
23	appropriated. The allottee of the funds appropriated
24	under section 2 of this act shall be the Governor of Yap
25	State EXCEPT THAT the funds appropriated under

subsection 2(i) shall be the President of COM-FSM. The
allottee of funds appropriated under sections 3 and 4 or
this act shall be the President of the Federated States
of Micronesia or his designee; EXCEPT THAT the funds
appropriated under subsections a, b, c, d, e, f, g, h,
i, j, k, l, m, n, o, s, t, u, v, w, x, ag, ah, aj, ap
and aq of section 3 this act shall be the Mayor of Lelu
Town Government or his designee; the allottee of funds
appropriated under subsections 3(y) and 3(ao) of this
act shall be the Governor of Kosrae or his designee; the
funds appropriated under subsections a, b, c, d, e, f
and g of section $4(1)$, subsections $4(3)(b)$, (c) , (d) ,
