

To further amend Public Law No. 18-11, as amended by Public Laws Nos. 18-44, 18-81, 19-33, 19-106, 19-128, 19-134, 19-138, 20-11, 20-49, 20-55, 20-62, 20-115, 21-14 and 21-126, by amending section 2 thereof, to extend the lapse date of funds previously appropriated therein, to assist the states of Pohnpei and Yap in retiring debt and covering budget shortfalls, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 18-11, as amended

2 by Public Laws Nos. 18-44, 19-128, 19-138, 20-11, 20-115 and

3 21-126, is hereby further amended to read as follows:

"Section 2. Allotment and management of funds and 4 lapse date.
