AN ACT

To further amend Public Law No. 19-121, as amended by Public Laws Nos. 19-130, 19-142, 19-145, 19-158, 20-09, 20-22, 20-51, 20-59, 20-70, 20-123, 20-162, 20-170, 21-35, 21-66, 21-112, 21-127, 21-176 and 21-198, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 19-121, as amended by
2 Public Laws Nos. 19-130, 19-142, 19-145, 20-22, 20-51 and 20-162, is
3 hereby further amended to read as follows:

4 "Section 4. Of the sum of \$5,450,000 appropriated by
5 this act, \$1,200,000 is apportioned to fund public
6 projects and social programs for the people of the state
7 of Pohnpei.

14 Section 2. Section 6 of Public Law No. 19-121, as amended
 15 by Public Laws Nos. 19-130, 19-142, 20-09, 20-70, 20-123, 20-162,
 16 20-170, 21-35, 21-66, 21-127 and 21-176, is hereby further
 17 amended to read as follows:

18 "Section 6. Allotment and management of funds and
 19 lapse date. All funds appropriated by this act shall
 20 be allotted, managed, administered and accounted for in
 21 accordance with applicable laws, including, but not
 22 limited to, the Financial Management Act of 1979. The
 23 allottee shall be responsible for ensuring that these
 24 funds, or so much thereof as may be necessary, are used
 25 solely for the purpose specified in this act, and that

1 no obligations are incurred in excess of the sum
2 appropriated. The allottee of the funds appropriated
3 under section 2 of this act shall be the Governor of
4 Yap State; PROVIDED THAT, the allottee of funds
5 appropriated under section 2(k) shall be the President
6 of the Federated States of Micronesia. The allottee of
7 funds appropriated under sections 3 and 4 of this act
8 shall be the President of the Federated States of
9 Micronesia or his designee; PROVIDED THAT the allottee
10 of funds appropriated under subsections 3(a) through
11 3(z) shall be the Governor of Kosrae State or his
12 designee; the allottee of funds appropriated under
13 subsections 3(aa) – 3(all) shall be the Mayor of Lelu
14 Town Government, or his designee EXCEPT THAT the
15 allottee of fund appropriated under subsection 3(au) of
16 this act shall be the Governor of Kosrae or his
17 designee; the allottee of funds appropriated under
18 subsection 4(1)(a) of this act shall be the Governor of
19 Pohnpei State or his designee; the allottee of funds
20 appropriated under subsections 4(1)(l), 4(2)(o),
21 4(3)(a), 4(3)(f) and 4(3)(i) of this act shall be the
22 Pohnpei Transportation Authority (PTA); the allottee of
23 funds appropriated under subsections 4(2)(a), 4(2)(d),
24 4(2)(e), 4(2)(f), 4(2)(g), 4(2)(h), 4(2)(i), 4(2)(j),
25 4(2)(k), 4(2)(l) and 4(2)(m) shall be the Secretary of

1 the Department of Transportation, Communications and
2 Infrastructure or his designee; the allottee of funds
3 appropriated under subsection 4(2)(b) shall be the
4 Pohnpei Utility Corporation (PUC); the allottee of
5 funds appropriated under subsection 4(2)(c) shall be
6 the Office of Fisheries, Pohnpei State; the allottee of
7 funds appropriated under subsection 4(2)(n) shall be
8 the Secretary of the Department of Education or his
9 designee; the allottee of funds appropriated under
10 subsection 4(3)(b) shall be the Pohnpei State Public
11 Safety; the allottee of funds appropriated under
12 subsections 4(3)(c) and 4(3)(e) of this act shall be the
13 Meninkeder of Madolenihmw; allottee of funds
14 appropriated under subsections 4(3)(d) and 4(3)(m)
15 shall be the Luhkenmoanlap of Kittu. The allottee of
16 funds appropriated under subsections 5(1) and 5(6) of
17 this act shall be the Governor of Chuuk State or his
18 designee. The allottee of funds appropriated under
19 subsection 5(2) of this act shall be the Mortlock
20 Islands Development Authority. The allottee of funds
21 appropriated under section 5(3) of this act shall be
22 the Mayor of Weno Municipal Government or his designee.
23 The allottee of funds appropriated under subsection
24 5(4) of this act shall be the Southern Namoneas
25 Development Authority. The allottee of funds

appropriated under subsection 5(5) of this act shall be
the Faichuk Development Authority. The authority of
the allottee to obligate funds appropriated by this act
shall lapse on September 30, 2022."

Section 3. This act shall become law upon approval by the
President of the Federated States of Micronesia or upon its
becoming law without such approval.
