

CONGRESSIONAL BILL NO. 22-297

AN ACT

To further amend Public Law No. 20-92, as amended by Public Laws Nos. 20-124, 20-161, 20-171, 21-41, 21-68, 21-134, 21-203 and 22-117, by amending section 3 thereof, for the purpose of changing the use of funds previously appropriated therein, to fund public projects and social programs for the people of Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Laws Nos. 20-92, as amended
2 by Public Law No. 21-203, is hereby further amended to read as
3 follows:

4 "Section 3. Of the \$1,400,000 appropriated under this
5 act, \$200,000 shall be apportioned for public projects
6 and social programs in the state of Kosrae.


