Dear Speaker Simina:

I am transmitting the following congressional act, which I have signed to become Public Law No. 22–131 with item veto as explained in this transmittal:

Congressional Act No. 22-128, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 21-180, AS AMENDED BY PUBLIC LAWS NOS. 21-191, 21-234, 21-240 AND 22-21, BY AMENDING SECTIONS 5 AND 6 THEREOF, TO CHANGE THE USE, ALLOTTEE AND LAPSE DATE OF FUNDS PREVIOUSLY APPROPRIATED THEREIN, FOR THE PURPOSE OF FUNDING PUBLIC PROJECTS AND SOCIAL PROGRAMS FOR THE PEOPLE OF POHNPEI AND CHUUK STATES, AND FOR OTHER PURPOSES."

I have been advised that funding under sec. 5(1)(d) for Fishing Project (\$35,000) was already allotted and partially expended; hence, the amendment in the act consisting of shifting said funding to sec. 5(1)(f) Tonoas Goodwill Games contributions cannot be accommodated at this time due to insufficient funds. I regret vetoing these two line items.



### AN ACT

To further amend Public Law No. 21-180, as amended by Public Laws Nos. 21-191, 21-234, 21-240 and 22-21, by amending sections 5 and 6 thereof, to change the use, allottee and lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 5 of Public Law No. 21-180, as amended by

6	Section 2. Section 6 of Public Law No. 21-180, as amended by
7	Public Laws Nos. 21-191, 21-234, 21-240 and 22-21, is hereby
8	further amended to read as follows:
9	"Section 6. Allotment and management of funds and lapse
10	date. All funds appropriated by this act shall be
11	allotted, managed, administered and accounted for in
12	accordance with applicable laws, including, but not
13	limited to, the Financial Management Act of 1979. The
14	allottee shall be responsible for ensuring that these
15	funds, or so much thereof as may be necessary, are used
16	solely for the purpose specified in this act, and that
17	no obligations are incurred in excess of the sum
18	appropriated. The allottee of the funds appropriated
19	under section 2 of this act shall be the Governor of Yap
20	State or his designee. The allottee of funds
21	appropriated under sections 3 and 4 of this act shall be
22	the President of the Federated States of Micronesia or
23	his designee; PROVIDED THAT; the allottee of funds
24	appropriated under subsections $4(1)(b)$ and $4(1)(c)$ of
25	this act shall be the Secretary of the Department of

Health and Social Affairs or his designee; the allottee of funds appropriated under subsection 4(1)(d) of this act shall be the Secretary of the Department of Justice or his designee; the allottee of funds appropriated under subsection 4(1)(e) of this act shall be the Secretary of the Department of Resources and Development or his designee; the allottee of funds appropriated under section 3(1) of this act shall be the Governor of Kosrae State or his designee; the allottee of funds appropriated under subsection 3(2) of this act shall be the Mayor of Lelu Town or his designee; the allottee of funds appropriated under subsections 4(1)(a), 4(1)(f), 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(d), 4(2)(e), 4(2)(f), 4(2)(q), 4(2)(h) and 4(3)(c) of this act shall be the Secretary of the Department of Transportation, Communications and Infrastructure; the allottee of funds appropriated under subsection 4(2)(i) of this act shall be the Chief Magistrate of Sokehs Municipal Government; the allottee of funds appropriated under subsections 4(3)(a) of this act shall be the Pohnpei Transportation Authority (PTA); the allottee of funds appropriated under subsection 4(3)(e) of this act shall be the Vice President of the Federated States of Micronesia or his designee; the allottee of funds appropriated under subsections 4(3)(b) and 4(3)(d) of this act shall be the
