A RESOLUTION

Requesting that the Speaker of the Twenty-Second Congress of the Federated States of Micronesia establish a Special Committee for the purpose of reviewing and investigating lawsuits filed in the FSM Supreme Court in which the parties are the FSM Development Bank and citizens of the Federated States of Micronesia, to investigate certain alleged wrongdoings and corruptions involving personnel of the FSM Development Bank and personnel of the FSM Supreme Court, in relation to the lawsuits, property disputes, and other related matters.

- 1 WHEREAS, the FSM Development Bank is a body corporate
- 2 established under title 30 of the Code of the Federated States of
- 3 Micronesia; and
- WHEREAS, the purpose of the FSM Development Bank is to
- 5 conduct its activities within the framework of the National
- 6 Government's economic plans, policies, and priorities, with the
- 7 overall goal of improving the lives of the people of the Federated
- 8 States of Micronesia; and
- 9 WHEREAS, impoverished citizens of the Federated States of
- 10 Micronesia continue to express their complaints and concerns
- 11 regarding lawsuits filed against said citizens, which has led to
- 12 the deterioration of lives of the people of the Federated States
- 13 of Micronesia: and
- 14 WHEREAS, the complaints and concerns include certain alleged
- 15 wrongdoings and corruptions involving personnel of the FSM
- 16 Development Bank and personnel of the FSM Supreme Court, in
- 17 relation to the lawsuits, property disputes, and other related

- 1 matters; and
- 2 WHEREAS, the aforementioned complaints and concerns have led
- 3 to a state of uncertainty regarding the FSM Development Bank's
- 4 primary role, which is to provide technical assistance and
- 5 services on loan projects to its borrowers to foster economic
- 6 activities for this nation thereby improving the quality of life
- 7 for the people of the Federated States of Micronesia; and
- 8 WHEREAS, Congress has determined that an urgent need arises
- 9 for a Special Committee to review, investigate, and report on
- 10 lawsuits filed in the FSM Supreme Court involving said parties and
- 11 the aforementioned complaints and concerns; and
- 12 WHEREAS, under Rule 6, Section 1, of the Official Rules of
- 13 Procedure of the Twenty-Second Congress of the Federated States of
- 14 Micronesia, the Speaker may establish a Special Committee to
- 15 consider and report on such matters; now, therefore,
- 16 BE IT RESOLVED by the Twenty-Second Congress of the Federated
- 17 States of Micronesia, First Regular Session, 2021, that Congress
- 18 hereby requests that the Speaker establish a Special Committee for
- 19 the purpose of reviewing lawsuits filed in the FSM Supreme Court
- 20 in which the parties involved are the FSM Development Bank and
- 21 citizens of the Federated States of Micronesia, to investigate
- 22 certain alleged wrongdoings and corruptions involving personnel of
- 23 the FSM Development Bank and personnel of the FSM Supreme Court,
- 24 in relation to the lawsuits, property disputes, and other related
- 25 matters; and
