

A BILL FOR AN ACT

To appropriate the sum of \$4,200,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2021, for the purpose of funding public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$4,200,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2021, for the purpose of funding public projects and
5 social programs in each of the states. The funds appropriated
6 under this section shall be apportioned as follows:

7 Section 2. Of the \$4,200,000 appropriated under this act,
8 \$600,000 shall be apportioned for public projects and social
9 programs for the people of Yap State.

10 state of Yap.....\$ 600,000

11 section 3. Of the \$4,200,000 appropriated under this act,
12 \$600,000 shall be apportioned for public projects and social
13 programs for the people of Kosrae State.

14 state of Kosrae..... 600,000

15 (1) At Large..... 300,000

1 Section 4. Of the \$4,200,000 appropriated under this act,
2 \$1,200,000 shall be apportioned for road improvement for the
3 people of Pohnpei State.

9 Section 5. Of the \$4,200,000 appropriated under this act,
10 \$1,800,000 shall be apportioned for road improvement for the
11 people of Chuuk State.

19 Section 6. Allotment and management of funds and lapse date.
20 All funds appropriated by this act shall be allotted, managed,
21 administered and accounted for in accordance with applicable laws,
22 including, but not limited to, the Financial Management Act of
23 1979. The allottee shall be responsible for ensuring that these
24 funds, or so much thereof as may be necessary, are used solely for
25 the purpose specified in this act, and that no obligations are

1 incurred in excess of the sum appropriated. The allottee of the
2 funds appropriated under section 2 of this act shall be the
3 Governor of Yap State or his designee. The allottee of funds
4 appropriated under section 3 of this act shall be the Governor of
5 Kosrae State or his designee. The allottee of funds appropriated
6 under section 4 of this act shall be the Governor of Pohnpei State
7 or his designee. The allottee of the funds appropriated under
8 sections 5(1) and 5(6) of this act shall be the Governor of Chuuk
9 State or his designee. The allottee of the funds appropriated
10 under section 5(2) of this act shall be the Mortlock Islands
11 Development Authority. The allottee of the funds appropriated
12 under section 5(3) of this act shall be the Mayor of Weno
13 Municipal Government or his designee. The allottee of the funds
14 appropriated under section 5(4) of this act shall be the Southern
15 Namoneas Development Authority. The allottee of the funds
16 appropriated under section 5(5) of this act shall be the Faichuk
17 Development Authority. The authority of the allottee to obligate
18 funds appropriated by this act shall lapse on September 30, 2023.

19 Section 7. This act shall become law upon approval by the
20 President of the Federated States of Micronesia or upon its
21 becoming law without such approval.
