A RESOLUTION

To approve and accept a \$2,343,536 grant from the United States Department of Education, Office of Special Education Programs, to fund and support the FSM Special Education Program for FY-2021, including all the terms and conditions of the assistance.

1 WHEREAS, the United States Department of Education issued a
2 Grant Award on August 30, 2021, to the Government of the Federated
3 States of Micronesia providing funding in the amount of \$2,343,536
4 for the purpose of providing support to the FSM Special Education
5 Program for FY-2021; and

6 WHEREAS, that the Government of the Federated States of
7 Micronesia wishes to express its appreciation and gratitude to the
8 U.S. Department of Education and the U.S. Government for extending
9 this grant; and

10 WHEREAS, this grant is considered a foreign financial
11 assistance that requires for its validity the approval by Congress
12 through resolution; now, therefore,

13 BE IT RESOLVED by the Twenty-Second Congress of the Federated
14 States of Micronesia, Fourth Special Session, 2022, that Congress
15 hereby approves and accepts the \$2,343,536 grant from the U.S.
16 Department of Education to provide funding for the FSM Special
17 Education Program for FY-2021, including all the terms and
18 conditions thereof; and




