A RESOLUTION

TO AMEND THE PRESIDENT'S DECLARATION OF STATE OF EMERGENCY FOR THE STATE OF CHUUK AS AMENDED ON JANUARY 14, 2022, BY EXTENDING THE DECLARATION OF EMERGENCY TO THE STATE OF YAP AS A DIRECT RESULT OF THE UNUSUAL TIDAL SURGE OR KING TIDE AFFECTING THE ISLANDS AND COMMUNITIES IN YAP, AND ASSISTANCE TO THE STATE OF YAP AS NEEDED AND WARRANTED UNDER THE STATE OF EMERGENCY TO MAY 31, 2022.

A RESOLUTION

To amend the President's Declaration of State of Emergency for the State of Chuuk as amended on January 14, 2022, by extending the Declaration of Emergency to the State of Yap as a direct result of the unusual tidal surge or King Tide affecting the islands and communities in Yap, and assistance to the state of Yap as needed and warranted under the state of emergency to May 31, 2022.

1 WHEREAS, it has come to the attention of Congress that the
2 State of Emergency should be extended to the State of Yap as a
3 result of the unusual tidal surge in the State of Yap; and

4 WHEREAS in accordance to Article X, Section 9 (c) of the
5 FSM Constitution, Congress has the sole authority to revoke,
6 amend or extend the President's Declaration of State of
7 Emergency for Chuuk; and

8 WHEREAS, Congress is currently convened for its Fourth
9 Special Session and therefore has the powers under the
10 Constitution to revoke, amend or extend the Declaration for the
11 State of Chuuk; now, therefore,

12 BE IT RESOLVED by the Twenty-Second Congress of the
13 Federated States of Micronesia, Fourth Special Session, 2022,
14 that unless sooner revoked by Congress, the Emergency
15 Declaration for Chuuk is extended to Yap and is in effect until
16 May 31, 2022; and

1 BE IT FURTHER RESOLVED, that certified copies of this
2 resolution be transmitted to the President of the Federated
3 States of Micronesia, the Chief Justice of the FSM Supreme
4 Court, the Governor of Yap State, and the presiding officers of
5 the Yap State Legislature.




