A RESOLUTION

Expressing the sincere condolences and sadness of the Twenty-Second Congress of the Federated States of Micronesia to the United States Congress and to the family of the late Don Young, United States Congressman from the state of Alaska, at his passing.

1           WHEREAS, the late Don Young was a longstanding supporter of  
2 the Federated States of Micronesia during his 25 terms in the  
3 United States Congress; and

4           WHEREAS, the late Don Young was first elected to the United  
5 States House of Representatives in 1973, representing the state  
6 of Alaska for 49 years in the United States Congress; and

7           WHEREAS, the late Don Young was the longest-serving member  
8 in the United States Congress, and served as the Chairman of the  
9 United States House Natural Resources Committee from 1995 to  
10 2001, Chairman of the United States House Transportation and  
11 Infrastructure Committee from 2001 to 2007, and Chairman of the  
12 United States House Natural Resources Subcommittee on Indian,  
13 Insular and Alaska Native Affairs from 2011 to 2017; and

14           WHEREAS, the late Don Young was publicly admired for his  
15 advocacy for the state of Alaska and legislative efforts to  
16 support Alaskan native and American Indian communities;

1           WHEREAS, the late Don Young worked to ensure the fair  
2 treatment of FSM citizens residing in the United States under the  
3 REAL ID Act Modification for Freely Associated States Act; and

4           WHEREAS, the late Don Young was committed to the Compact of  
5 Free Association between the Federated States of Micronesia and  
6 the United States, and made many contributions to the nation;  
7 now, therefore,

8           BE IT RESOLVED, by the Twenty-Second Congress of the  
9 Federated States of Micronesia, Fourth Special Session, 2022,  
10 that Congress hereby expresses its sincere condolences and  
11 sadness to the United States Congress and to the family of the  
12 late Don Young at his passing, and
