A RESOLUTION

Approving and accepting a \$50,000 grant from the United Nations Education, Scientific and Cultural Organization (UNESCO), to support the project in the FSM entitled: "UNESCO-GPE-FSM Internet Connected Learning Platform Space (ICLPS)", including all the terms and conditions of the assistance.

1 WHEREAS, on May 28, 2021, the Federated States of Micronesia
2 through the Acting Secretary of the Department of Education, and
3 the United Nations Education, Scientific and Cultural Organization
4 (UNESCO) concluded an Implementation Partners Agreement providing
5 the FSM with a \$50,000 grant in connection with a project
6 entitled: "UNESCO-GPE-FSM Internet Connected Learning Platform
7 Space (ICLPS)", according to the terms and conditions of the
8 implementation of this project; and

9 WHEREAS, this is an agreement on the receipt of foreign
10 financial assistance that requires for its validity the approval
11 by Congress through resolution in accordance with section 210(2)
12 of title 55 of the Code of the Federated States of Micronesia
13 (Annotated) as amended; and

14 WHEREAS, that the Government of the Federated States of Micronesia
15 wishes to express its appreciation to the UNESCO for the generous
16 grant extended to the Federated States of Micronesia; now,
17 therefore,

18 BE IT RESOLVED by the Twenty-Second Congress of the Federated
19 States of Micronesia, Fourth Regular Session, 2022, that Congress
20 hereby approves and accepts the \$50,000 grant to support the

1 Implementation Partners Agreement for the UNESCO-GPE-FSM Internet
2 Connected Learning Platform Space Project (ICLPS), including all
3 the terms and conditions thereof; and

4 BE IT FURTHER RESOLVED that certified copies of this
5 resolution be transmitted to the President of the Federated States
6 of Micronesia, the Secretary of the Department of Education, the
7 Secretary of the Department of Finance and Administration, and the
8 Secretary of the Department of Justice.


