A RESOLUTION

Approving and accepting a grant in the amount of \$109,991 from the U.S. Department of Health and Human Services, Health Resources and Services Administration, to fund the FSM Maternal Child Health Program and its services for the budget period from December 04, 2021, to February 18, 2022, including all the terms and conditions of the assistance.

1 WHEREAS, the United States through the Department of Health
2 and Human Services, Health Resources and Services Administration,
3 issued a Notice of Grant Award on December 17, 2021, in the amount
4 of \$109,991; and

5 WHEREAS, the purpose of the grant is to fund and support the
6 implementation and development of the FSM Maternal Child Health
7 Program and its services to improve the health and well-being of
8 mothers, families, and children, for better coordination of a
9 system of care for the maternal and child health population,
10 particularly vulnerable populations who do not have access to
11 adequate health care in the FSM; and

12 WHEREAS, section 210(2) of title 55 of the Code of the
13 Federated States of Micronesia, (Annotated), as amended, provides
14 that for foreign financial assistance to be valid it must be
15 approved by Congress by resolution; now, therefore,

16 BE IT RESOLVED by the Twenty-Second Congress of the Federated
17 States of Micronesia, Fourth Regular Session, 2022, that Congress
18 hereby approves and accepts the \$109,991 grant in from the U.S.

1 Department of Health and Human Services, Health Resources and
2 Services Administration, to fund and support the FSM Maternal
3 Child Health Program and its services, including all the terms and
4 conditions thereof; and

5 BE IT FURTHER RESOLVED that certified copies of this
6 resolution be transmitted to the President of the Federated States
7 of Micronesia, the Secretary of the Department of Health and
8 Social Affairs, the Secretary of the Department of Justice and the
9 Secretary of the Department of Foreign Affairs.


