A RESOLUTION

Authorizing the President to resubmit the nomination of Mr. Samson E. Pretrick to serve as a member of the MiCare Board of Directors, representing the National Government.

1           WHEREAS, during the First Special Session of the Twenty  
2 Second Congress the President submitted the nomination of Mr.  
3 Samson E. Pretrick to serve as a member of the MiCare Board of  
4 Directors, representing the National Government; and

5           WHEREAS, the resolution approving the nomination has not  
6 been adopted by Congress; and

7           WHEREAS, under section 207 of title 2 of the Code of the  
8 Federated States of Micronesia (Annotated), as amended, any  
9 nomination not acted upon within two consecutive sessions of  
10 Congress may not be resubmitted by the President during the  
11 Twenty-Second Congress without authorization from Congress;  
12 now, therefore,

13           BE IT RESOLVED, by the Twenty-Second Congress of the  
14 Federated States of Micronesia, Fourth Regular Session, 2022,  
15 that Congress hereby authorizes the President to resubmit the  
16 nomination of Mr. Samson E. Pretrick to serve as a member of the  
17 MiCare Board of Directors, representing the National Government;  
18 and

1           BE IT FURTHER RESOLVED, that certified copies of this  
2 resolution be transmitted to the President of the Federated  
3 States of Micronesia and Mr. Samson E. Pretrick.


