A RESOLUTION

Approving and accepting a grant in the amount of \$275,841 from the United States Department of Health and Human Services, Office of the Secretary of Health, to support and fund the FSM Department of Health and Social Affairs' Family Planning Program, including all the terms and conditions of the assistance.

1 WHEREAS, on May 05, 2022, the United States Department of
2 Health and Human Services, Office of the Secretary of Health,
3 issued to the second Notice of Award in the amount of \$275,841, to
4 fund and support the FSM Family Planning Program and its services
5 for the budget period from May 15, 2022 to May 31, 2023; and

6 WHEREAS, the purpose of this grant is to fund and support the
7 implementation of the FSM Family Planning Program to create equity
8 by improving services, quality and increasing services to the
9 hard-to-reach vulnerable populations in the FSM through expansion
10 of the Pohnpei State Telehealth Network; and

11 WHEREAS, section 210(2) of title 55 of the Code of the
12 Federated States of Micronesia (Annotated), as amended, provides
13 that for foreign financial assistance to be valid, it must be
14 approved by Congress by resolution; now, therefore,

15 BE IT RESOLVED by the Twenty-Second Congress of the Federated
16 States of Micronesia, Fourth Regular Session, 2022, that Congress
17 hereby approves and accepts the \$275,841 grant from the U.S.
18 Department of Health and Human Services, Office of the Secretary
19 for Health, to fund and support the FSM Family Planning Program

1 and its services, including all the terms and conditions thereof;

2 and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated States
5 of Micronesia, the Secretary of the Department of Health and
6 Social Affairs, the Secretary of the Department of Justice and the
7 Secretary of the Department of Foreign Affairs.
