A RESOLUTION

Approving and accepting a grant in the amount of ¥400,000,000 from the Government of Japan, to provide funding for the purchase of four small patrol boats for the Government of the Federated States of Micronesia, including all the terms and conditions of assistance.

1           WHEREAS, the Government of Japan committed to providing a  
2 grant in the amount of ¥400,000,000 (approximately, USD 3.7  
3 million) as evidenced by the Exchange of Notes dated June 3, 2022,  
4 between the Government of the FSM and the Government of Japan, for  
5 the purchase of four small patrol boats for the FSM Government;

7           WHEREAS, this is considered a foreign financial assistance  
8 that requires for its validity the approval by Congress through  
9 resolution; and

10          WHEREAS, the Government of the Federated States of Micronesia  
11 wishes to express its appreciation and gratitude to the Government  
12 of Japan for this generous grant; now, therefore,

13          BE IT RESOLVED by the Twenty-Second Congress of the Federated  
14 states of Micronesia, Fifth Special Session, 2022, that Congress  
15 hereby approves and accepts the aforesaid grant from the  
16 Government of Japan, including all the terms and conditions  
17 thereof; and


1 BE IT FURTHER RESOLVED that certified copies of this


