A RESOLUTION

To approve and accept a grant in the amount of \$144,220 from the U.S. Department of Health and Human Services, Health Resources and Services Administration, to support and fund the Universal Newborn Hearing Screening and Intervention Program, for the budget period from April 01, 2022, to March 31, 2023, including all the terms and conditions of the assistance.

1 WHEREAS, on May 26, 2022, the United States Department of
2 Health and Human Services, Health Resources and Services
3 Administration (HRSA), issued the Notice of Award for financial
4 assistance in the amount \$144,220 to fund and support the program
5 entitled: "Universal Newborn Hearing Screening and Intervention"
6 for the budget period from April 01, 2022, to March 31, 2023; and

7 WHEREAS, the purpose of this is to fund and support the
8 continuation of the Universal Newborn Hearing Screening and
9 Intervention Program and its related activities in the FSM; and

10 WHEREAS, section 210(2) of title 55 of the Code of the
11 Federated States of Micronesia (Annotated), as amended, requires
12 that for foreign financial assistance to be valid it must be
13 approved by Congress by resolution; now, therefore,

14 BE IT RESOLVED by the Twenty-Second Congress of the Federated
15 states of Micronesia, Fifth Special Session, 2022, that Congress
16 hereby approves and accepts the \$144,220 grant from the U.S.
17 Department of Health and Human Services, Health Resources and
18 Services Administration, to fund the Universal Newborn Hearing

1 Screening and Intervention Program, including all the terms and
2 conditions thereof; and

3 BE IT FINALLY RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated States
5 of Micronesia, the Secretary of the Department of Health and
6 Social Affairs, the Secretary of the Department of Foreign
7 Affairs, and the Secretary of the Department of Justice.




