A RESOLUTION

Approving and accepting a grant in the amount of \$220,849 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to fund the FSM Comprehensive Cancer Control Program for the budget period from June 30, 2022, to June 29, 2023, including all the terms and conditions of the assistance.

1 WHEREAS, on May 26, 2022, the United States through the
2 Department of Health and Human Services, Centers for Disease
3 Control and Prevention, issued a Notice of Award in the amount of
4 \$220,849, to fund the FSM Comprehensive Cancer Control Program;
5 and

6 WHEREAS, section 210(2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended, requires
8 that for foreign financial assistance to be valid it must be
9 approved by Congress by resolution; and

10 WHEREAS, the FSM Government expresses appreciation to the
11 United States Government for the federal grant programs made
12 available to the Federated States of Micronesia; now, therefore,

13 BE IT RESOLVED by the Twenty-Second Congress of the Federated
14 States of Micronesia, Fifth Regular Session, 2022, that Congress
15 hereby approves and accepts the \$220,849 grant from the United
16 States Department of Health and Human Services, Centers for
17 Disease Control Prevention, to provide funding to the FSM
18 Comprehensive Cancer Control Program, including all the terms and
19 conditions thereof; and


1 BE IT FURTHER RESOLVED that certified copies of this
