A RESOLUTION

Approving and accepting a grant in the amount of \$176,686 from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Centers for Substance Abuse Treatment, to provide funding support to the FSM Behavioral Health and Wellness Program and its related activities and services, including all the terms and conditions of the assistance.

1           WHEREAS, on February 10, 2022, the U.S. Department of Health  
2 and Human Services Substance Abuse and Mental Health Services  
3 Administration, Centers for Substance Abuse Treatment, issued a  
4 Notice of Award in the amount of \$176,686 to the FSM Department of  
5 Health and Social Affairs; and

6           WHEREAS, the purpose of the grant is to provide funding to  
7 support, plan, implement, and evaluate activities that prevent and  
8 treat substance abuse in the FSM; and

9           WHEREAS, section 210(2) of title 55 of the Code of the  
10 Federated States of Micronesia (Annotated), as amended, requires  
11 that for foreign financial assistance to be valid it must be  
12 approved by Congress by resolution; now, therefore,

13           BE IT RESOLVED by the Twenty-Second Congress of the Federated  
14 States of Micronesia, Fifth Regular Session, 2022, that Congress  
15 hereby approves and accepts the \$176,686 grant from the United  
16 States Department of Health and Human Services, Substance Abuse  
17 and Mental Health Services Administration, Centers for Substance  
18 Abuse Treatment, to provide funding support to the FSM Department  
19 of Health and Social Affairs for the prevention and treatment  
20 services related to substance abuse, including all the terms and

1 conditions thereof; and

2 BE IT FURTHER RESOLVED that certified copies of this  
3 resolution be transmitted to the President of the Federated States  
4 of Micronesia, the Secretary of the Department of Health and  
5 Social Affairs, the Secretary of the Department of Justice, the  
6 Secretary of the Department of Foreign Affairs, and the U.S.  
7 Embassy in Kolonia.


