A RESOLUTION

Approving and accepting a grant in the amount of \$1,418,517 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to support and fund the FSM Immunization and Vaccines for Children Program, including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. Department of Health and Human Services
2 Health, Centers for Disease Control and Prevention, issued a
3 Notice of Award in the amount of \$1,418,517, to fund the FSM
4 Immunization and Vaccines for Children Program for the budget
5 period from July 01, 2022, to June 30, 2023; and

6 WHEREAS, the grant shall support the FSM Immunization and
7 Vaccines for Children Program's activities and efforts in
8 planning, developing, and maintaining a public health workforce
9 that helps assure high immunization coverage levels and low
10 incidence of vaccine-preventable diseases, as well as improving
11 the ability to respond to public health threats; and

12 WHEREAS, section 210(2) of title 55 of the Code of the
13 Federated States of Micronesia (Annotated), as amended, provides
14 that for foreign financial assistance to be valid it must be
15 approved by Congress by resolution; now, therefore,

16 BE IT RESOLVED by the Twenty-Second Congress of the Federated
17 States of Micronesia, Fifth Regular Session, 2022, that Congress
18 hereby approves and accepts the \$1,418,517 grant from the U.S.
19 Department of Health and Human Services, Centers for Disease

1 Control and Prevention, to fund the FSM Immunization and Vaccines
2 for Children Program, including all the terms and conditions
3 thereof; and

4 BE IT FURTHER RESOLVED that certified copies of this
5 resolution be transmitted to the President of the Federated States
6 of Micronesia, the Secretary of the Department of Health and
7 Social Affairs, the Secretary of the Department of Justice and the
8 United States Embassy in Kolonia.


