A RESOLUTION

Approving and accepting a grant in the amount of \$220,562 from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Center for Mental Health Services, to fund and support the Community Mental Health Services Project in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, on May 20, 2022, the United States through the
2 Department of Health and Human Services, Substance Abuse and
3 Mental Health Services Administration, Center for Mental Health
4 Services issued a Notice of Award in the amount of \$220,562 to the
5 Federated States of Micronesia, Department of Health and Social
6 Affairs, to fund the Community Mental Health Services Project,
7 managed by the FSM Behavioral Health and Wellness Program; and

8 WHEREAS, the purpose of the grant is to fund and support the
9 implementation of the Community Mental Health Services Project and
10 its activities in providing mental health prevention services and
11 treatment services to its patients in the FSM; and

12 WHEREAS, section 210(2) of title 55 of the Code of the
13 Federated States of Micronesia (Annotated), as amended, provides
14 that for foreign financial assistance to be valid it must be
15 approved by Congress by resolution; now, therefore,

16 BE IT RESOLVED by the Twenty-Second Congress of the Federated
17 States of Micronesia, Fifth Regular Session, 2022, that Congress
18 hereby approves and accepts the \$220,562 grant from the U.S.

1 Department of Health and Human Services, Substance Abuse and
2 Mental Health Services Administration, Center for Mental Health
3 Services, to fund the FSM Community Mental Health Services Project
4 and its related activities, including all the terms and conditions
5 thereof; and

6 BE IT FURTHER RESOLVED that certified copies of this
7 resolution be transmitted to the President of the Federated States
8 of Micronesia, the Secretary of the Department of Health and
9 Social Affairs, the Secretary of the Department of Justice and the
10 United States Embassy in Kolonia.




