A RESOLUTION

Approving and accepting a grant in the amount of \$478,510 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to fund the FSM Public Health and Hospital Emergency Preparedness Program, including all the terms and conditions of the assistance.

1 WHEREAS, on June 28, 2022, the United States through the
2 Department of Health and Human Services, Centers for Disease
3 Control and Prevention, issued a Notice of Award in the amount of
4 \$478,510 to fund and support the FSM Program entitled: "FSM Public
5 Health and Hospital Emergency Preparedness"; and

6 WHEREAS, the grant will fund and support the continuation of
7 the FSM Public Health and Hospital Emergency Preparedness Program
8 in its continued effort and work progress, especially with the
9 roll out of vaccines to combat COVID-19 for the budget period
10 starting from July 01, 2022, to June 30, 2023; and

11 WHEREAS, section 210(2) of title 55 of the Code of the
12 Federated States of Micronesia (Annotated), as amended, requires
13 that for foreign financial assistance to be valid it must be
14 approved by Congress by resolution; now, therefore,

15 BE IT RESOLVED by the Twenty-Second Congress of the Federated
16 States of Micronesia, Fifth Regular Session, 2022, that Congress
17 hereby approves and accepts the \$478,510 grant from the U.S.
18 Department of Health and Human Services, Centers for Disease
19 Control and Prevention, to fund the FSM Public Health and Hospital
20 Emergency Preparedness Program, including all the terms and

1 conditions thereof; and

2 BE IT FURTHER RESOLVED that certified copies of this
3 resolution be transmitted to the President of the Federated States
4 of Micronesia, the Secretary of the Department of Health and
5 Social Affairs, the Secretary of the Department of Foreign
6 Affairs, the Secretary of the Department of Finance and
7 Administration, the Secretary of the Department of Justice, and
8 the U.S. Embassy in Kolonia.
