A RESOLUTION

To approve and accept a \$183,061 grant from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA), to fund the FSM Substance Abuse, Prevention, and Treatment Block Grant 2022, including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. Department of Health and Human Services
2 SAMHSA issued a Grant Award on August 3, 2022, to the Government

4 amount of \$183,061 for the purpose of providing support to the FSM
5 Substance Abuse, Prevention, and Treatment Block Grant 2022; and

6 WHEREAS, this grant is considered a foreign financial
7 assistance that requires for its validity the approval by Congress
8 through resolution; and

9 WHEREAS, that the Government of the Federated States of
10 Micronesia wishes to express its appreciation and gratitude to the
11 U.S. Department of Health and Human Services SAMHSA and the U.S.
12 Government for extending this grant; now, therefore

15 aforesaid financial grant from U.S. Department of Health and Human
16 Services SAMHSA is hereby accepted and approved, including all the


1 BE IT FURTHER RESOLVED that certified copies of this


