2 the Federated States of Micronesia (Annotated), the President

4 MiCare Board of Directors, representing the National Government;

6           WHEREAS, the 22<sup>nd</sup> FSM Congress invited the President to  
7 resubmit the nomination of Mr. Pretrick through Congressional  
8 Resolution No. 22-128; and

9           WHEREAS, Mr. Predrick is qualified to serve in this  
10 capacity based on his educational background and long years of  
11 experience in public service, including his current position as  
12 Director of Personnel; and

13           WHEREAS, appointment to the MiCare Board of Directors  
14 requires the advice and consent of the Congress of the Federated  
15 States of Micronesia; now, therefore,

16           BE IT RESOLVED by the Twenty-Second Congress of the  
17 Federated States of Micronesia, Fifth Regular Session, 2022,  
18 that the nomination of Mr. Samson E. Predrick to serve as a  
19 member of the MiCare Board of Directors representing the  
20 National Government is hereby confirmed; and


1 BE IT FURTHER RESOLVED that certified copies of this
