11 WHEREAS, the late Dr. Vita Akapito Skilling completed her
12 medical education training at the Pacific Basin Medical Officers
13 Training Program of the University of Hawaii, John Burn's
14 School of Medicine in 1992, completed her residency in
15 Pediatrics at the Fiji School of Medicine, completed her post-
16 graduate distance learning from the University of Otago in New
17 Zealand, and completed her undergraduate education from Grand
18 Valley State University in 1977; and

19 WHEREAS, the late Dr. Skilling contributed important health

1 policies that benefited this nation, as well as, the state of
2 Kosrae during her many years of service in the health profession
3 and was very well respected by her colleagues and citizens; and

4 WHEREAS, with her extensive experience in the health
5 profession, late Dr. Vita Akapito Skilling continued to guide
6 our Nation forward contributing not only to our development, but
7 to the growth and well-being of the whole Pacific region; now,
8 therefore,


