

A RESOLUTION

To confirm the nomination of Mr. Jeem S. Lippwe to serve as the Permanent Representative of the Federated States of Micronesia to the United Nations.

1           WHEREAS, the President of the Federated States of  
2 Micronesia has nominated Mr. Jeem S. Lippwe to serve as the  
3 Permanent Representative of the Federated States of Micronesia  
4 to the United Nations; and

5           WHEREAS, the nomination is subject to the advice and  
6 consent of Congress pursuant to section 2(d), Article X, of the  
7 Constitution of the Federated States of Micronesia and title 2  
8 F.S.M.C.§207 (Annotated); and

9           WHEREAS, Mr. Lippwe is a highly experienced diplomat  
10 having served since 2003 as Deputy Permanent Representative of  
11 the Federated States of Micronesia to the United Nations and is  
12 currently the Charge d' Affairs in the Permanent Mission to the  
13 United Nations in New York; and

14           WHEREAS, Mr. Lippwe represented the FSM Government in many  
15 foreign affairs matters for over two decades; and

16           WHEREAS, Mr. Lippwe served as Minister at the FSM  
17 permanent Mission since 1999 and was Deputy Assistant Secretary  
18 for Multilateral Affairs from 1992 up to 1999; and

19           WHEREAS, Mr. Lippwe possesses the essential qualifications  
20 that make him a suitable candidate to serve as the FSM

1 Permanent Representative to the United Nations; now, therefore,  
2 BE IT RESOLVED by the Twenty-Second Congress of the  
3 Federated States of Micronesia, Fifth Regular Session, 2022,  
4 that the nomination of Mr. Jeem S. Lippwe to serve as the  
5 Permanent Representative of the Federated States of Micronesia  
6 to the United Nations is hereby confirmed; and


7 BE IT FURTHER RESOLVED that certified copies of this


