A RESOLUTION

Approving and accepting a grant in the amount of \$433,053 from the United States Department of Health and Human Services, through the Assistant Secretary of Preparedness and Response, to fund the FSM Public Health and Hospital Emergency Preparedness Program, including all the terms and conditions of the assistance.

1 WHEREAS, on August 01, 2022, the United States through the
2 Department of Health and Human Services, Assistant Secretary of
3 Preparedness and Response, issued a Notice of Award of a grant in
4 the amount of \$433,053, to fund and support the FSM Program
5 entitled: "FSM Public Health and Hospital Emergency Preparedness";
6 and

7 WHEREAS, the grant will fund and support the implementation
8 of the FSM Public Health and Hospital Emergency Preparedness
9 Program in its continued effort and work progress, especially with
10 the roll out of vaccines to combat COVID-19 for budget period
11 starting from July 01, 2022, to June 30, 2023; and

12 WHEREAS, section 210(2) of title 55 of the Code of the
13 Federated States of Micronesia (Annotated), as amended, requires
14 that for foreign financial assistance to be valid it must be
15 approved by Congress by resolution; now, therefore,

16 BE IT RESOLVED by the Twenty-Second Congress of the Federated
17 States of Micronesia, Fifth Regular Session, 2022, that Congress
18 hereby approves and accepts the \$433,053 grant from the U.S.
19 Department of Health and Human Services, Assistant Secretary for
20 Preparedness and Response, to fund the FSM Public Health and

1 Hospital Emergency Preparedness Program, including all the terms
2 and conditions thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated States
5 of Micronesia, the Secretary of the Department of Health and
6 Social Affairs, the Secretary of the Department of Foreign
7 Affairs, the Secretary of the Department of Finance and
8 Administration, the Secretary of the Department of Justice, and
9 the U.S. Embassy in Kolonia.


