A RESOLUTION

Approving and accepting a donation in the amount of \$200,000 by the Government of the People's Republic of China to implement measures against the COVID-19 pandemic, including all the terms and conditions of the assistance.

1 WHEREAS, the Government of the People's Republic of China
2 donated \$200,000 through its Embassy in Pohnpei for the use by
3 the FSM Government to implement appropriate measures against
4 the COVID-19 pandemic and to purchase necessary medical
5 supplies and equipment; and

6 WHEREAS, this is considered a foreign financial assistance
7 that requires for its validity the approval by Congress through
8 resolution; and

9 WHEREAS, the Government of the Federated States of
10 Micronesia wishes to express its appreciation and gratitude to
11 the Government of the People's Republic of China for this
12 generous donation; now, therefore,

13 BE IT RESOLVED by the Twenty-Second Congress of the
14 Federated States of Micronesia, Sixth Special Session, 2022,
15 that Congress hereby approves and accepts the \$200,000 donation
16 by the Government of the People's Republic of China to
17 implement measures against the COVID-19 pandemic, including all
18 the terms and conditions thereof,


1 BE IT FURTHER RESOLVED that certified copies of this


