A RESOLUTION

Approving and accepting a grant in the amount of \$131,774 from the U.S Department of Health and Human Services, Health Resources and Services Administration, to fund the FSM Maternal Child Health Program for the budget period from October 01, 2021, to the September 30, 2023, including all the terms and conditions of the assistance.

1           WHEREAS, the United States through the Department of  
2 Health and Human Services, Health Resources and Services  
3 Administration, issued a Notice of Award on July 28, 2022, in  
4 the amount of \$131,774; and

5           WHEREAS, the purpose of the grant is to fund and support  
6 the implementation and development of the FSM Maternal Child  
7 Health Program and its services to improve the health and well-  
8 being of mothers, families, and children, for better  
9 coordination of a system of care for the maternal and child  
10 health population, particularly vulnerable populations who do  
11 not have access to adequate health care in the FSM; and

12           WHEREAS, section 210 (2) of title 55 of the Code of the  
13 Federated States of Micronesia (Annotated), as amended,  
14 provides that for foreign financial assistance to be valid it  
15 must be approved by Congress by resolution; now, therefore,

16           BE IT RESOLVED by the Twenty-Second Congress of the  
17 Federated States of Micronesia, Sixth Special Session, 2022,  
18 that Congress hereby approves and accepts the \$131,774 grant  
19 from the U.S Department of Health and Human Services, Health

1 Resources and Services Administration, to fund and support the  
2 FSM Maternal Child Health Program and its services, including  
3 all the terms and conditions thereof; and

4 BE IT FURTHER RESOLVED that certified copies of this  
5 resolution be transmitted to the President of the Federated  
6 States of Micronesia, the Secretary of the Department of Health  
7 and Social Affairs, the Secretary of the Department of Justice,  
8 and Secretary of the Department of Foreign Affairs, and the  
9 U.S. Embassy in Kolonia.
