A RESOLUTION

To approve and accept a grant in the amount of \$119,000 from the U.S. Department of Agriculture, through the Forest Service Bipartisan Infrastructure Law (BIL), to fund the FSM Forest Action Plan activities, including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. Department of Agriculture (USDA) issued a
2 Grant Award on September 17, 2022, to the Government of the
3 Federated States of Micronesia providing funding in the amount of
4 \$119,000 to fund the FSM Action Plan Implementation -Forest
5 Stewardship Program (FSP), Grant Management & Capacity Building
6 for the Urban Community & Forestry (UCF) Program; and

7 WHEREAS, this grant is considered a foreign financial
8 assistance that requires for its validity the approval by Congress
9 through resolution; and

10 WHEREAS, the Government of the Federated States of Micronesia
11 wishes to express its appreciation and gratitude to the USDA and
12 the U.S. Government for extending this grant; now, therefore,

13 BE IT RESOLVED by the Twenty-Second Congress of the Federated
14 States of Micronesia, Sixth Special Session, 2022, that the
15 aforesaid financial grant from the USDA is hereby accepted and
16 approved, including all terms and conditions thereof; and


1 BE IT FURTHER RESOLVED that certified copies of this


