Approving and accepting a grant in the amount of SDR 12,700,000 (special drawing rights) from the World Bank to fund the FSM Skills and Employability Enhancing Project (SEEP), including all the terms and conditions of the assistance.

1 WHEREAS, the Secretary of Finance and Administration
2 representing the Federated States of Micronesia and the Country
3 Director for PNG & Pacific Islands representing the World Bank
4 signed a Financing Agreement on May 11, 2022 and May, 2022,
5 respectively, providing a grant to the Federated States of
6 Micronesia in the amount of SDR 12,700,000 (special drawing
7 rights) in order to fund the FSM Skills and Employability
8 Enhancement Project (SEEP); and

9 WHEREAS, this is considered a foreign financial assistance
10 that requires for its validity the approval by Congress through
11 resolution; and


12 WHEREAS, that the Government of the Federated States of


1 BE IT FURTHER RESOLVED that certified copies of this
