A RESOLUTION

Approving and accepting a grant in the amount of \$250,000 from the United States Department of Education for the budget period August 1, 2022 to July 31, 2023 under Part B of the Individual with Disabilities Education Act (IDEA), including all the terms and conditions of the assistance.

1 WHEREAS, the United States through the Department of
2 Education issued a Grant Award Notification dated September 12,
3 2022, for the budget period August 1, 2022 to July 31, 2023, in
4 the amount of \$250,000; and

5 WHEREAS, the purpose of the grant is to fund and assist the
6 implementation of a project in the FSM entitle: "Special
7 Education-Personnel Development to Improve Services and Results
8 for Children with Disabilities"; and

9 WHEREAS, section 210(2) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended, requires
11 that for foreign financial assistance to be valid it must be
12 approved by Congress by resolution; and


13 WHEREAS, the Government of the Federated States of Micronesia

19 States Department of Education, including all the terms and
20 conditions thereof, be approved; and


1 BE IT FURTHER RESOLVED that certified copies of this
