A RESOLUTION

Setting the ceiling of the total funds estimated to be available for appropriation from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2023.

1 WHEREAS, section 104 of title 55 of the Code of the
2 Federated States of Micronesia (Annotated), as amended, requires
3 that Congress adopt a resolution setting forth the total funds
4 estimated to be available for appropriation from the General Fund
5 and any special funds of the National Treasury of the Federated
6 States of Micronesia for each fiscal year; now, therefore,

7 BE IT RESOLVED by the Twenty-Second Congress of the
8 Federated States of Micronesia, Sixth Special Session, 2022, that
9 the amount estimated to be available for appropriation for the
10 fiscal year ending September 30, 2023, is set at \$ 107,090,963 of
11 which \$104,189,854 is from domestic revenues, and \$1,000,000 will
12 be available from the Amended Compact sector grant and \$1,901,109
13 will be available from the Supplemental Education Grant; and


1 BE IT FURTHER RESOLVED that certified copies of this


