Approving and accepting a grant in the amount of \$500,000 from the United States Department of the Interior, Office of Insular Affairs (OIA), to fund the FSM Single Audit for FY2022 as required under the Amended Compact, including all the terms and conditions of the assistance.

1           WHEREAS, on October 20, 2022, the U.S. Department of the  
2 Interior-OIA issued a grant to the Federated States of  
3 Micronesia in the amount \$500,000; and

4           WHEREAS, the purpose of the grant is to provide funding for  
5 the FSM Single Audit for Fiscal Year 2022 as required under the  
6 Amended Compact; and

7           WHEREAS, the grant is subject to the approval of Congress  
8 by resolution; and

9           WHEREAS, the Government of the Federated States of  
10 Micronesia wishes to express its appreciation to the United  
11 States for the grant; now, therefore,

12           BE IT RESOLVED by the Twenty-Second Congress of the  
13 Federated States of Micronesia, Sixth Regular Session, that  
14 Congress hereby approves and accepts the \$500,000 grant from  
15 the U.S. Department of Interior – OIA, to fund the FSM Single  
16 Audit for Fiscal Year 2022, including all the terms and  
17 conditions thereof; and


