A RESOLUTION

Requesting that the Speaker of the Twenty-Second Congress of the Federated States of Micronesia instruct the Committees on Judiciary and Governmental Operations and Resources and Development to conduct oversight regarding alleged wrongdoings and corruptions involving personnel of the FSM Development Bank, in relation to the lawsuits, property disputes, and other related matters.

1           WHEREAS, the FSM Development Bank is a body corporate  
2 established under title 30 of the Code of the Federated States of  
3 Micronesia; and

4           WHEREAS, the purpose of the FSM Development Bank is to  
5 conduct its activities within the framework of the National  
6 Government's economic plans, policies, and priorities, with the  
7 overall goal of improving the lives of the people of the Federated  
8 States of Micronesia; and

9           WHEREAS, impoverished citizens of the Federated States of  
10 Micronesia continue to express their complaints and concerns  
11 regarding lawsuits filed against said citizens, which has led to  
12 the deterioration of lives of the people of the Federated States  
13 of Micronesia; and

14           WHEREAS, the complaints and concerns include certain alleged  
15 wrongdoings and corruptions involving personnel of the FSM  
16 Development Bank, in relation to the lawsuits, property disputes,  
17 and other related matters; and

18           WHEREAS, the aforementioned complaints and concerns have led

1 to a state of uncertainty regarding the FSM Development Bank's  
2 primary role, which is to provide technical assistance and  
3 services on loan projects to its borrowers to foster economic  
4 activities for this nation thereby improving the quality of life  
5 for the people of the Federated States of Micronesia; and

6 WHEREAS, Congress has determined that an urgent need arises  
7 for oversight regarding and the aforementioned complaints and  
8 concerns; now, therefore,

9 BE IT RESOLVED by the Twenty-Second Congress of the Federated  
10 States of Micronesia, First Regular Session, 2021, that Congress  
11 hereby requests that the Speaker instruct the Committees on  
12 Judiciary and Governmental Operations and Resources and  
13 Development to conduct oversight regarding alleged wrongdoings and  
14 corruptions involving personnel of the FSM Development Bank, in  
15 relation to the lawsuits, property disputes, and other related  
16 matters; and

17 BE IT FURTHER RESOLVED that the Committees on Judiciary and  
18 Governmental Operations and Resources and Development shall report  
19 their findings to Congress and make recommendations for further  
20 actions no later than the first regular session of 2022; and


