1 WHEREAS, on 04 November, 2022, the International Fund for
2 Agricultural Development provided a grant to the Government of the
3 Federated States of Micronesia in the amount of \$1,785,000; and

4 WHEREAS, the purpose for this grant is to provide financial
5 support to strengthen the improvement of sustainable and healthy
6 food, water security, and overall diet in the Federated States of
7 Micronesia; and

8 WHEREAS the grant shall be financed through a contribution
9 from the Global Agriculture and Food Security Programme (GAFSP);
10 and

11 WHEREAS the lead project agency shall be the National
12 Department of Resource and Development; and

13 WHEREAS, the grant is subject to certain terms and
14 conditions; now, therefore,

15 BE IT RESOLVED by the Twenty-Second Congress of the Federated
16 States of Micronesia, Seventh Special Session, 2023, that Congress
17 hereby approves and accepts the \$1,785,000 SIFWaP grant, including
18 all the terms and conditions thereof; and


