A RESOLUTION

Approving and accepting the grant from the U.S. Department of Health and Human Services, Office of the Assistant Secretary of Health, in the amount of \$368,300 for the budget period April 01, 2022 to March 31, 2024 for Family Planning Services in the FSM for FY-24, including all the terms and conditions of the assistance.

1 WHEREAS, on 18 March, 2023, the Government of the Federated
2 States of Micronesia received a grant from the U.S. Department of
3 Health and Human Services, Office of the Assistant Secretary of
4 Health; and

5 WHEREAS, the purpose for this grant is to provide financial
6 support to improve the quality and reach of Family Planning
7 Services in the Federated States of Micronesia; and

8 WHEREAS, the budget period is from April 01, 2022 to March
9 31, 2024; and

10 WHEREAS, section 210(2) of title 55 of the Code of the
11 Federated States of Micronesia (Annotated), as amended, requires
12 that foreign financial assistance must be approved by Congress by
13 resolution; and

14 WHEREAS, the grant is subject to certain terms and
15 conditions; now, therefore,

16 BE IT RESOLVED by the Twenty-Second Congress of the Federated
17 States of Micronesia, Seventh Special Session, 2023, that Congress
18 hereby approves and accepts the \$368,300 grant from U.S.

1 Department of Health and Human Services, Office of the Assistant
2 Secretary of Health, including all the terms and conditions
3 thereof; and


4 BE IT FURTHER RESOLVED that a certified copy of this


