To approve and accept a \$59,975 grant from the Forum Fisheries Agency to fund the Blue Prosperity Micronesia Coordinator salary and associated costs, including all the terms and conditions of the assistance.

1 WHEREAS, the Forum Fisheries Agency (FFA) issued a Grant
2 Award on September 18, 2020, to the Government of the Federated
3 States of Micronesia providing funding in the amount of \$59,975 to

7 assistance that requires for its validity the approval by Congress

4 Secretary of the Department of Foreign Affairs.




