A RESOLUTION

Approving and accepting a grant in the amount of \$488,764 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to fund the FSM Public Health and Hospital Emergency Preparedness Project, including all the terms and conditions of the assistance.

1 WHEREAS, on May 12, 2021, the United States through the
2 Department of Health and Human Services, Centers for Disease
3 Control and Prevention, issued a Notice of Award in the amount of
4 \$488,764 to fund and support the project entitled: "FSM Public
5 Health and Hospital Emergency Preparedness Project" and

6 WHEREAS, the purpose of the grant is to fund and support the
7 implementation of the FSM Public Health and Hospital Emergency
8 Preparedness Project for the budget period starting from July 01,
9 2021, to June 30, 2022; and

10 WHEREAS, section 210(2) of title 55 of the Code of the
11 Federated States of Micronesia (Annotated), as amended, requires
12 that for foreign financial assistance to be valid it must be
13 approved by Congress by resolution; now, therefore,

14 BE IT RESOLVED by the Twenty-Second Congress of the Federated
15 States of Micronesia, First Special Session, 2021, that Congress
16 hereby approves and accepts the \$488,764 grant from the U.S.
17 Department of Health and Human Services, Centers for Disease
18 Control and Prevention, to fund the FSM Public Health and Hospital
19 Emergency Preparedness Project, including all the terms and

1 conditions thereof; and

2 BE IT FURTHER RESOVED that certified copies of this
3 resolution be transmitted to the President of the Federated States
4 of Micronesia, the Secretary of the Department of Health and
5 Social Affairs, the Secretary of the Department of Foreign
6 Affairs, the Secretary of the Department of Finance and
7 Administration, the United States Embassy in Kolonia.




