3 Administration (HRSA) issued a Notice of Grant Award in the amount
4 of \$131,009, to fund and support the Maternal and Child Health
5 Services (MCHS) of the FSM Department of Health and Social
6 Affairs' Family Planning Program; and

7 WHEREAS, this grant is considered a foreign financial
8 assistance that requires for its validity the approval by Congress
9 through resolution; and

10 WHEREAS, the Government of the Federated States of Micronesia
11 wishes to express its appreciation and gratitude to the U.S.
12 Government for extending this grant; now, therefore,

13 BE IT RESOLVED by the Twenty-Second Congress of the Federated
14 States of Micronesia, First Special Session, 2021, that Congress
15 hereby approves and accepts the grant in the amount of \$131,009
16 from the U.S. Department of Health and Human Services HRSA to fund
17 the FSM's MCHS Family Planning Program, including all the terms
18 and conditions of the grant; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated States
3 of Micronesia, the Secretary of the Department of Justice and the
4 Secretary of the Department of Foreign Affairs.


