A RESOLUTION

To approve and accept a \$1,000,000 grant from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Center for Mental Health Services, to fund the FSM System of Care Expansion and Sustainability Project, including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. Department of Health and Human Services
2 issued a Grant Award on July 22, 2021, to the Government of the
3 Federated States of Micronesia providing funding in the amount of
4 \$1,000,000 for the purpose of providing support to the FSM System
5 of Care Expansion and Sustainability Project; and

6 WHEREAS, this grant is considered a foreign financial
7 assistance that requires for its validity the approval by Congress
8 through resolution; and

9 WHEREAS, that the Government of the Federated States of
10 Micronesia wishes to express its appreciation and gratitude to the
11 U.S. Government for extending this grant; now, therefore,

12 BE IT RESOLVED by the Twenty-Second Congress of the Federated
13 States of Micronesia, Second Special Session, 2021, that Congress
14 hereby approves and accepts the \$1,000,000 grant from U.S.
15 Department of Health and Human Services, including all the terms
16 and conditions thereof; and


