A RESOLUTION

To approve and endorse the Overseas Development Assistance (ODA) nationwide priorities of the Federated States of Micronesia.

1           WHEREAS, the ODA policy adopted by Congress provides for six  
2 (6) priorities to be officially endorsed and approved by Congress;  
3 and

4           WHEREAS, the nationwide priorities identified are as follows:

- 5           (1) Vocational School with a Dual Vocational Education and  
6 Training (VET) System;  
7           (2) Diagnostic Facility;  
8           (3) Water Security System for the FSM;  
9           (4) The Pave the Nation Initiative;  
10           (5) Renewable Energy; and  
11           (6) Climate Resilient Infrastructure for Outer Island  
12 Transport; and

13           WHEREAS, the President of the Federated States of Micronesia  
14 is requesting Congress to endorse the foregoing priorities; now,  
15 therefore,

16           BE IT RESOLVED by the Twenty-Second Congress of the  
17 Federated States of Micronesia, Third Regular Session, 2022, that  
18 Congress hereby approves the six (6) nationwide priorities stated  
19 above; and

1 BE IT FURTHER RESOLVED that the Congress of the Federated  
2 States of Micronesia is requesting the President to pursue the  
3 implementation of the priorities as effectively and expeditiously  
4 as possible; and

5 BE IT FURTHER RESOLVED that certified copies of this  
6 resolution be transmitted to the President of the Federated States  
7 of Micronesia and the Governor of each state of the Nation.


