To approve and accept a \$200,000 grant from the United States Department of Education, Office of Special Education Programs (OSEP), to provide support to the FSM Special Education Program FY-2022, including all the terms and conditions of the assistance.

1 WHEREAS, the United States Department of Education issued a
2 Grant Award on September 30, 2021, to the Government of the
3 Federated States of Micronesia providing funding in the amount of
4 \$200,000 for the purpose of providing support to the FSM Special
5 Education Program for the budget period from 10/01/2021 to
6 9/30/22; and

7 WHEREAS, this grant is considered a foreign financial
8 assistance that requires for its validity the approval by Congress
9 through resolution; and


10 WHEREAS, the Government of the Federated States of Micronesia
