1           WHEREAS, pursuant to section 201(1), of title 24 of the  
2 Code of the Federated States of Micronesia (Annotated), the  
3 Federated States of Micronesia established a five-member Board  
4 of Directors for the National Oceanic Resource Management  
5 Authority; and

6           WHEREAS, pursuant to section 201(1)(b) of title 24  
7 F.S.M.C., (Annotated) the President of the Federated States of  
8 Micronesia nominates one member from each state to serve on the  
9 Board of Directors of NORMA, in consultation with each state  
10 governor and with the advice and consent of Congress; and

11           WHEREAS, pursuant to section 201(1)(a) of title 24  
12 F.S.M.C., (Annotated) the President has nominated Mr. Peter  
13 Garamfel, a nominee recommended by the Governor of the state of  
14 Yap, to serve as the Yap State representative on the Board of  
15 Directors of NORMA; and

16           WHEREAS, Mr. Peter Garamfel has the experience and  
17 qualifications which make him a suitable candidate to continue  
18 to serve on the NORMA Board of Directors; and


19           WHEREAS, board members are appointed to serve a two-year  
20 term; now, therefore,


1 BE IT RESOLVED by the Twenty-Second Congress of the
