

A RESOLUTION

Approving and accepting a grant in the amount of \$250,000 from the United States Department of Education to fund and support Federated States of Micronesia in its project entitled: "CURRENT", including all the terms and conditions of the assistance.

1 WHEREAS, on July 3, 2021, the United States Department of
2 Education issued a Notice of Grant Award in the amount of
3 \$250,000, to fund and support the FSM Department of Education,
4 Division of Special Services, in its project entitled "CURRENT" -
5 commitment to retaining new teachers; and

6 WHEREAS, the Government of the Federated States of Micronesia
7 wishes to express its sincere gratitude and appreciation to the
8 Government of the United States of America for this generous
9 grant; and

10 WHEREAS, the purpose of this grant is to support the FSM and
11 its Department of Education by providing funding for the first
12 year of the project CURRENT; and

13 WHEREAS, the project period is from October 1, 2021 to
14 September 30, 2026, and the budget period for this grant award is
15 from October 1, 2021 to September 30, 2022; and

16 WHEREAS, this is a foregin financial assistance as defined
17 under section 210(1)(b) of title 55 of the Code of the Federated
18 States of Micronesia (Annotated), as amended; and

19 WHEREAS, section 210(2) of title 55 of the Code of the

1 Federated States of Micronesia (Annotated), as amended, requires
2 that in order for foreign financial assistance to be valid it must
3 be approved by Congress by resolution; now, therefore,

4 BE IT RESOLVED by the Twenty-Second Congress of the Federated
5 States of Micronesia, Third Special Session, 2021, that Congress
6 hereby approves and accepts this \$250,000 grant award from U.S.
7 Department of Education, to fund and support the FSM Department of
8 Education in its activities relating the project CURRENT; and

9 BE IT FURTHER RESOLVED the certified copies of this
10 resolution be transmitted to the President of the Federated States
11 of Micronesia, the Secretary of the Department of Education, the
12 Secretary of the Department of Foreign Affairs and the Secretary
13 of the Department of Justice.


