A RESOLUTION

To approve and accept a \$5,000,000 grant from the Asian Development Bank (the "ADB") to provide funding for the FSM Sustainable Road Infrastructure Investment Project, including all the terms and condition of the assistance.

1 WHEREAS, the ADB issued a Grant Award on November 15,
2 2021, to the Government of the Federated States of Micronesia
3 providing funding in the amount of \$5,000,000 for the purpose
4 of providing support to the FSM Sustainable Road infrastructure
5 Investment Project; and

6 WHEREAS, this grant is considered a foreign financial
7 assistance that requires for its validity the approval by
8 Congress through resolution; and

9 WHEREAS, that the Government of the Federated States of
10 Micronesia wishes to express its appreciation and gratitude to
11 the ADB for extending this grant; now, therefore,

12 BE IT RESOLVED by the Government of the Federated States
13 of Micronesia, Third Special Session, 2021, that Congress
14 hereby approves and accepts the \$5,000,000 grant from the ADB,
15 to fund the FSM Sustainable Road Infrastructure Investment
16 Project, including all the terms and conditions thereof; and




