A RESOLUTION

Setting the ceiling of the total funds estimated to be available for appropriation from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2022.

1           WHEREAS, section 104 of title 55 of the Code of the Federated  
2 States of Micronesia (Annotated), as amended, requires that Congress  
3 adopt a resolution setting forth the total funds estimated to be  
4 available from the General Fund and any special funds estimated of  
5 the Treasury of the Federated States of Micronesia for each fiscal  
6 year; now, therefore,

7           BE IT RESOLVED by the Twenty-Second Congress of the Federated  
8 States of Micronesia, Third Regular Session, 2022, that the amount  
9 estimated to be available for the fiscal year ending September 30,  
10 2022, is set at \$106,175,505 of which \$103,633,303 is from domestic  
11 revenues, and \$1,000,000 will be available from the Amended Compact  
12 sector grant and \$1,542,202 will be available from the Supplemental  
13 Education Grant; and


