

A RESOLUTION

Approving and accepting a grant in the amount of \$1,000,000 from the Government of the United States through the American Rescue Plan Act Supplemental EDA Award for Statewide Planning Grant, including all the terms and conditions of the assistance.

1           WHEREAS, the Government of the United States committed to  
2 providing funding assistance to the FSM Government in the amount  
3 of \$1,000,000 to support a project in FSM entitled: "ARPA  
4 Statewide Planning for the Federated States of Micronesia to  
5 Develop Agricultural and Fisheries Industries"; and

6           WHEREAS, section 210(2) of title 55 of the Code of the  
7 Federated States of Micronesia (Annotated), as amended, provides  
8 that for foreign financial assistance to be valid it must be  
9 approved Congress by resolution; and

10           WHEREAS, that the FSM Government expresses appreciation to  
11 the Government of the United States for its generosity; and

12           BE IT RESOLVED by the Twenty-Second Congress of the Federated  
13 States of Micronesia, Third Regular Session, 2022, that Congress  
14 hereby approves and accepts the \$1,000,000 grant from the U.S.  
15 Government as described above, including all the terms and
