

A RESOLUTION

To approve and accept a \$24,130 grant from the World Meteorological Organization (WMO) to provide support for the FSM -National Weather Service, including all the terms and conditions of the assistance.

1 WHEREAS, the WMO issued a grant award on September 01, 2021,
2 to the Government of the Federated States of Micronesia providing
3 funding in the amount of \$24,130 for the purpose of providing
4 financial support for the development and logistical arrangement
5 of its National Strategic Plan and Fremework for Weather, Water
6 and Climate Services with Action Plans for the FSM - National
7 Weather Service; and

8 WHEREAS, this grant is considered a foreign financial
9 assistance that requires for its validity the approval by Congress
10 through resolution; now, therefore,

11 BE IT RESOLVED by the Twenty-Second Congress of the Federated
12 States of Micronesia, Third Regular Session, 2022, that Congress
13 hereby approves and accepts the \$24,130 grant from WMO, to provide
14 support to the FSM-National Weather Services, including all the
15 terms and conditions thereof; and


