TO AMEND RULE 6, SECTIONS 8(C) AND (D) OF THE OFFICIAL RULES OF PROCEDURE OF THE TWENTY-THIRD CONGRESS OF THE FEDERATED STATES OF MICRONESIA TO ALLOW A STANDING COMMITTEE CHAIR TO SERVE AS VICE CHAIR OF THE COMMITTEE ON WAYS AND MEANS.

A RESOLUTION

To amend Rule 6, Sections 8(c) and (d) of the Official Rules of Procedure of the Twenty-Third Congress of the Federated States of Micronesia to allow a standing committee chair to serve as vice chair of the Committee on Ways and Means.

- 1 WHEREAS, the Congress of the Federated States of
- 2 Micronesia is governed by its Official Rules of Procedure; and
- 3 WHEREAS, Sections 8(c) and 8(d) of Rule 6 of the
- 4 Official Rules of Procedure of the Twenty-Third Congress
- 5 of the Federated States of Micronesia provide that a
- 6 Member of Congress who serves as chair of a standing
- 7 committee may not serve as vice chair of another standing
- 8 committee; and
- 9 WHEREAS, the role of the vice chair of a standing
- 10 committee is to perform the duties of the chair in the
- 11 absence of the chair; and
- 12 WHEREAS, a Congressional Resolution is an acceptable
- 13 mechanism for amending the Official Rules of Procedure of
- 14 Congress under Rule 15 of the Official Rules of Procedure; and
- 15 WHEREAS, the Members of the Twenty-Third Congress of the
- 16 Federated States of Micronesia wish to allow the Committee on
- 17 Ways and Means to have a permanent vice chair; now, therefore,
- 18 BE IT RESOLVED by the Twenty-Third Congress of the
- 19 Federated States of Micronesia, First Regular Session, 2023,

1 that Rule 6, Section 8 of the Official Rules of Procedure of

- the Twenty-Third Congress of the Federated States of Micronesia
- 3 is hereby amended to read as follows:
- 4 "Section 8. Chair and vice chair
 - (a) The chair of each standing committee or special committee, and the chair for each continuous session of the Committee of the Whole, shall be appointed by the Speaker, subject to appeal to the Congress. A vice chair shall be chosen by the members of each standing committee.
 - (b) The chair of each committee shall call meetings, preside at committee meetings, prepare and post the agenda, invite witnesses to appear before the committee, and prepare committee reports subject to the requirements of the Rules. The vice chair shall perform the duties of the chair in his or her absence.
 - (c) A Member of Congress who serves as chair of a standing committee may not serve as chair or vice chair of another standing committee, except that such Member may serve as vice chair of the Committee on Ways and Means. The Speaker, Vice Speaker and Floor Leader may not serve as chair or vice chair of any standing committee."
