Approving and accepting a grant in the amount of \$2,564,294 from the United States Department of Education for the Fiscal Year 2024 under Part B of the Individual with Disabilities Education Act (IDEA), to fund the FSM Special Education Program and its services, including all the terms and conditions of the assistance.

1           WHEREAS, the United States through the Department of  
2 Education issued a Notice of Award for the second phase of the  
3 IDEA grant in the amount of \$2,564,294 for the federal funding  
4 period from July 1, 2023, to September 30, 2024; and

5           WHEREAS, the purpose of the grant is to fund and support the  
6 implementation of the FSM Special Education Program; and

7           WHEREAS, section 210 (2) of title 55 of the Code of the  
8 Federated States of Micronesia (Annotated), as amended, requires  
9 that for foreign financial assistance to be valid it must be  
10 approved by Congress by resolution; now, therefore,

11           BE IT RESOLVED by the Twenty-Third Congress of the Federated  
12 States of Micronesia, Third Regular Session, 2024, that Congress  
13 hereby approves and accepts the \$2,564,294 grant from the United  
14 States Department of Education, to fund the FSM Special Education  
15 Program and its services, including all the terms and conditions  
16 thereof; and
